## Supply, Delivery, Installation, Testing and Commissioning of Solar Street Lighting System in Lalitpur Sub Metropolitan City ward no 1 to 30.

1. The Government of Nepal (GoN) has allocated funds and Lalitpur Sub Metropolitan City (LSMC) Office received grants from GoN, LSMC now invites sealed bids or electronic bids from all registered eligible and qualified Bidders/suppliers the **Supply, Delivery, Installation, Testing and Commissioning of Solar Street Lighting System in Lalitpur Sub Metropolitan City Ward no. 1 to 30** under National Competitive Bidding procedures as per the required specifications mentioned in bid document.
2. Interested eligible bidders may obtain further information and inspect the bidding documents at the Lalitpur Sub Metropolitan City Office, Pulchowk, Lalitpur, Nepal or may visit PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np).
3. A complete set of Bidding Documents may be purchased from Lalitpur Sub Metropolitan City Office during office hours on all working days by eligible bidders **20 October 2016** onwards on the submission of a **Written Application**, copies of **Firm/Institution Registration** and **PAN/VAT Registration** certificates and upon payment of a non-refundable fee of **NRs. 3000.00**. The Bidding Documents shall be available for sale up to office hours till **18 November 2016**. Bidders who choose to submit their bid electronically may purchase the hard copy of bidding documents as mentioned above or may download the bidding document for e submission from PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders submitting their bid electronically should deposit the bidding document cost as non refundable fee of NRs. 3,000.00 to Nepal Bank Limited, Gabahal Branch, Current Account Number 180-3000000004003007 and the scanned copy of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of bids.
4. Pre-bid meeting shall be held at Lalitpur Sub Metropolitan City Office, Pulchowk, Lalitpur, Nepal at **2.00 P.M. on 8 November 2016**.
5. Sealed bids must be submitted to the above office on or before **12:00 Noon on 20 November 2016**. Documents received after this deadline shall not be accepted.
6. Bids must be valid for a period of **90 days**, counting from the day of bid opening and must be accompanied by bid security, amounting as given below in the name of Lalitpur Sub Metropolitan City Office, which shall be valid for minimum **30 days** beyond the bid validity period. The bid security shall conform to the standard format as specified in the bid document.
7. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Bank Account No 018000000003000038 at **Nepal Bank Limited, Gabahal Branch**, and submit the original receipt of the deposited amount of cash along with the Bid.
8. Bids shall be opened in the presence of Bidders' representatives who choose to attend at **2:00 P.M. on 20 November 2016** at Lalitpur Sub Metropolitan City Office, Pulchowk, Lalitpur, Nepal. But nothing shall bar the opening of Tender by the reason only that any bidder or its agent is not present. Bidder's representative should come with authorization duly signed by the authority of firm at the time of bid opening.
9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
10. Lalitpur Sub Metropolitan City Office shall not be responsible for any costs or expenses incurred by bidders in connection with the preparation or submission of Bids. The bidders are advised to visit and assess the actual site conditions before submitting their bid.
11. Lalitpur Sub Metropolitan City Office reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
12. The bidders who submit the bid electronically are requested to submit all the original hard copy documents including bid document within 7<sup>th</sup> day after bid submission date at Lalitpur Sub Metropolitan City Office, Pulchowk, Lalitpur, Nepal.
